WHEREAS: the Board of County Commissioners, Pittsburg County, pursuant to the authority granted to the Board by Section 16-26.B of Title 2 of the Oklahoma Statutes, do hereby proclaim that extreme fire danger exists in Pittsburg County. This situation (as defined in Section 16-26.B.1 a-d, Title 2, O.S.) has been verified by a documented concurrence of the majority of the County's municipal managers and rural fire chiefs, of their designees.

WHEREAS: By virtue of this resolution, it is unlawful for any person to set fire to any forest, grass, range, crop, or other wildlands, or to build a campfire or bonfire, or to burn trash or other material that may cause a forest, grass, range, crop or other wildlands fire.

WHEREAS: Any law enforcement office of the State of Oklahoma may carry out the enforcement of this resolution. Any person convicted of violating this resolution shall be guilty of a misdemeanor and shall be subject to a fine or not more than Five Hundred Dollars (\$500.00), to imprisonment of not more than one (1) year, or to both such fine and imprisonment.

WHEREAS: Certain exceptions are attached to this resolution by Pittsburg County.

NOW THEREFORE, BE IT RESOLVED: That the Board of County Commissioners, Pittsburg County, made this COUNTY WIDE BURN BAN, effective immediately for a period not to exceed 7 days from the date of passage by the Board of County Commissioners. If extreme fire danger conditions persist, subsequent resolutions may be passed. This Burn Ban may be removed at any time during the seven day period by the same method by which it was approved.

## **EXCEPTIONS to the Pittsburg County Burn Ban**

### **FOR EQUIPMENT RELATED TO ROAD CONSTRUCTION PROJECTS**

Equipment which uses propane or other controlled type burners is generally regarded as safe, however, it would be prudent to have a water pumper on standby any time this equipment is used near a grassy right of way.

### **WELDING/CUTTING TORCH/GRINDING ACTIVITIES**

When conducted over a non-combustible surface of at least 10 feet by 10 feet and when welding blankets or screens are used to cover flammable vegetation; and.

- a. Wind speeds must be less than 20 mph; and
- b. A fire watch, other than the welder, is posted at the welding/cutting torch site with pressurized water for fire extinguisher.

### **CAMPFIRES AND OUTDOOR COOKING**

Outdoor campfires or bonfires are prohibited. LPG and natural gas and charcoal-fired cooking outside in a grilling receptacle are permitted provided that the activity is conducted over a non-flammable surface and at least five feet from flammable vegetation.
